



# AM I PARTICIPATING IN A PENSION PLAN?

## 1. START WITH YOUR PAY STUB!

Look for contributions made to “LAPP” or “Public Service Pension Plan (PSPP).”

- This is how much you and your employer are putting towards your pension.
- Your employer should at least MATCH your contributions (meaning they should be equal to or more than your own contributions).
